DRAW TICKETS

PROCURE issues a maximum of 10,000 tickets, numbered from 1 to 10,000, allowing you to participate in the drawing for a trip for two people to Paris, France from May 9 to 14, 2024 (value of \$11,600) and a trip for two people to Cancun, Mexico (value of \$7,000).

Tickets, costing \$100 each, are on sale from February 12 to April 24, 2024, at noon (EST) inclusively via an online purchase form on the PROCURE organization's website and its online Shopify store.

Participation in the draw is reserved for any natural person residing in Quebec and aged 18 and over. Employees of the PROCURE organization, members of the board of directors, and people residing at the same address cannot participate in the drawing.

No ticket purchase can be canceled or refunded and it does not entitle you to any tax receipt.

PRIZE DESCRIPTION

Prize #1: Trip for 2 people to Paris (France)

Details of the trip to be won:

- Prize valid for 2 people with a total value of \$11,600
- Travel dates: May 9 to 14, 2024.
- Air Canada economy class round-trip flight from Montreal to Paris (value: \$3,000)
- 4 nights at the 4-star Meliá Paris La Défense hotel (value: \$2,500)
- 1 prepaid credit card allowance worth \$1,000

Trip itinerary:

- Thursday, May 9: Departure from Montreal
- Friday, May 10: Arrival in Paris
- Friday, May 10: 2 tickets for Taylor Swift's The Eras Tour concert at Paris La Défense Arena at 7 p.m. (value: \$3,000).
- Saturday, May 11: Free visit day
- Sunday, May 12: 2 tickets for Paris Saint Germain against Toulouse FC soccer match at Parc des Princes at 9 p.m. (value: \$1,000).

- Monday, May 13: 2 "Tasting Menu" dinners with wine pairing at the restaurant L'Orangerie - Four Seasons Hotel George V, at 7:30 p.m. (value: \$1,100) *Additional expenses will be at the charge of the winner.
- Tuesday, May 14: Return flight to Montreal.

Prize #2: Trip for 2 people to Cancun (Mexico)

Details of the trip to be won:

- Round-trip Transat economy class flight from Montreal to Cancún (value: \$2,000)

PRIZE DRAW

Any participation implies the publication of the name of the winner. The winner will be contacted by telephone or email by the PROCURE organization within 2 days following the draw.

Reservations and travel arrangements must be made through the PROCURE organization representative.

PAYMENT METHOD

Payment for the drawing ticket at \$100 must be paid in full by credit card via the PROCURE website. No limit on the number of tickets purchased per participant.

CONDITIONS FOR TRAVEL

1. The Prize has no cash value and the dates of the activities are fixed. The winner may transfer the Prize to any individual aged 18 and over.
2. All additional costs not included in the activities detailed in the trip description must be entirely borne by the winner.
